ADILABAD
Illicit liquor smuggling

A person was arrested for allegedly smuggling illicit liquor locally known as Desi Daru produced in Maharashtra at Pardi village in Adilabad Rural mandal. Police seized 48 bottles containing 180 ml of liquor each and a two-wheeler from him. Adilabad Prohibition and Excise Inspector Vijayender said a person was booked for smuggling illicit liquor seized during a raid held at the village. The officials conducted raids in three parts, following a tip-off.

19 Maoists surrender in Kothagudem

In a setback to the CPI (Maoist) party, 19 naxals from Chhattisgarh surrendered before the police in Kothagudem on Thursday. They surrendered before Superintendent of Police B Rohith Raju, CRPF 81 battalion and 141 battalion officials at Bhadrachalam.

The Maoist agriculture team south Bastar divisional committee member Naroti Manish, PLGA 1st battalion People's Party Committee Members (PPCM) Madvi Nanda and Madvi Handa, the battalions People's Militia member Madvi Hadama and Nimmalagudem Revolutionary People's Commit-

tee commander Madakam Deva were among the surrendered naxals, the SP informed.

Cash reward
Naroti Manish carries a cash reward of Rs 8 lakh while Madvi Nanda and Madvi Handa carry a cash reward of Rs 4 lakh each. They were given the cash cheques of the reward amount by the SP Rohith Raju.

He told the media that in January, an Athmeeya Sammelanam was organised with the family members of the surrendered Maoists at Cherala to explain about the benefits of surrendering to police and schemes offered by the government to live a normal life. In that pro-

gramme, 22 Maoists surrendered before the police.

The above Maoists realised that that party has lost support of adivasis, extorting money and hindering development of agency villages and surrendered to police, Rohith Raju said. He appealed to underground naxals to quit the party and surrender to police to join mainstream life.

Life convict hurls slipper at judge

A life convict hurled a slipper at the ninth Additional District Judge in the Ranga Reddy court complex at LB Nagar on Thursday.

The man was three days ago convicted and sentenced to life imprisonment in an attempt to murder case registered at Jagathgirigutta police station.

He was later sent to Central Prison Cherlapally.

Police and advocates overpowered the man and dragged him out of the court hall. He was given a sound thrashing and later handed over to the local police

On Thursday, the man was again brought to the LB Nagar court and was to be produced before the same judge in connection with a murder case registered at Narsingi police station.

"The man asked the es-

cort constables that he wanted to speak to the judge and asked them to remove handcuffs. The man went inside the court hall and abused the lady judge and then hurled a slipper which fell a little away," said LB

Nagar Inspector, K Vinod Kumar.

Soon the police and the advocates overpowered the man and dragged him out of the court hall. He was given a sound thrashing and later handed over to the local police. Based on a complaint, the police are registering a case against him.

The advocates boycotted the court work in protest against the attack demanding stringent action against the convict.

Mystery shrouds student's death in tribal hostel

After learning about their ward's death, the parents and relatives turned up at the hostel. Holding the hostel staff responsible for the student's death, they even tried to attack the staff members. Sensing trouble, the police arrived at the hostel and brought the situation under control. Amidst police security, the post-mortem was being conducted, the reports said.

A farmer Dasari Yellaiah had kept his cattle in a shed on the outskirts of the village on Wednesday. When he returned to the shed on Thursday, he found the half eaten carcass of one of the calves. He immediately called Forest and police officials. Forest officials, who confirmed it was a leopard behind the attack, suggested that the villagers not venture into the forest area until the leopard retreats deep into the forest. Officials also asked the villagers not to move alone in the agriculture fields located on the forest fringe.

Seven officials suspended over irregularities

Seven secretaries of the Marketing Department, including two from erstwhile Adilabad district, were suspended for their alleged role in irregularities in registration of cotton farmers in Warangal region. An order to this effect was issued by the region director Uppala Srinivas on Wednesday.

Madhukar Kamble from Adilabad market yard, Ramjaneyulu of Chennai, P Nirmala (Warangal, Srinivas (Janagama), Parameshwar (Chinna Koduru), Namala Srinivas (Bhadradi Kothagudem) and Prithvi Raj (Peddapalli) were placed under suspension based on a report submitted by the officials, who probed allegations against the secretaries.

Probe initiated

The department initiated a probe into the irregular-

ities when farmer associations lodged a complaint against the officials, alleging that large-scale discrepancies took place in issuance of temporary registrations.

Secretaries issue registrations to farmers
The secretaries issue the registrations to farmers enabling them to sell the cotton produce at procurement centres operated by Cotton Corporation of India (CCI).

The officials of the Marketing department reportedly issued the registrations to farmers who don't grow the cotton by colluding with unauthorised traders of the cotton, duping the Cotton Corporation of India. They allegedly accepted huge amounts as commission for doing the favour. Certain officials of the agriculture department were learnt to be under the scanner for their role in the irregularities.

Supermarket owner suicide: Wife blames moneylenders

The suicide of Saideep supermarket owner Mallikarjuna Ramesh (54) took a new turn, with his wife filing a complaint accusing moneylenders of harassing her husband.

Ramesh's wife, Gayathri, filed a complaint at town police station on Thursday. In her complaint, Gayathri alleged that Ramesh borrowed Rs 30 crore from 30 different lenders in the town when he took up the construction of the supermarket building.

She said that there was evidence in CCTV footage when they threatened her husband. She said her husband left for the supermarket at 7.30 am on Feb 11 to open the shop. However, he returned home soon after as the moneylenders threatened him with serious consequences unless he returned the amount.

Ramesh later hanged himself to death in his penthouse the same day.

Govt attaches property worth Rs 14.2 cr of chit fund firms

Perala Srinivas Rao from SBH colony, Vaddepalli of Hanamkonda, Suraneni Kondala Rao from Gopala-

pur of Hanamkonda, Puppala Rajender from Vishnupuri, Kazipet of Hanamkonda, Aluvula Varaprasad and Gone Ramesh were booked under various sections by Karimnagar Town-I police.

Following this, the Karimnagar Commissioner of Police requested the government to attach the properties under Telangana Financial Establishment Depositors Protection Act, 1999.

Based on the request, the government issued the GO attaching properties including land worth Rs 11.50 crore (50 acres) in Vedire of Ramadugu mandal and land worth Rs 2.70 crore (24,606 square yards) in Velichala of Ramadugu mandal.
